FORMAT All players will play in preliminary **RR** group of 3-4 players and 1-2 player(s) will advance into the **SE** play-off round. All matches are 3 out of 5 games except for finals of Event 1 (Open) which is 4 out of 7 games. Tournament committee reserves the right to modify prize money and/or cancel any event if there are insufficient entries. No prize money shall be awarded for splits and/or unfinished matches. **NO EXCEPTIONS.**

ENTRY DEADLINE Entries must be postmarked no later than **Saturday April 17, 2010**. Late entries will be accepted with a \$10 late fee subject to space availability.

ENTRY POLICY/RATINGS All entries must include full payment in order to be included in the draw(s). USATT ratings as of **Saturday, April 17, 2010** will be used.

ELIGIBILITY All players must be

USATT members. Please bring your USATT membership card or receipt. Non-members must join USATT at the tournament. Unrated players may play in any event, but unrated RR group winner will not be allowed to advance except Open Singles. Only in Open Singles, unrated RR group winner can advance to play-off round.

DEFAULT POLICY All ITTF/USATT regulations apply. Players must abide by all USATT rules. Players not registered within 10 minutes after starting time of the Event may be defaulted from that Event and without refund of entry fee. If a rating Event is canceled or has reached its limit, player(s) will automatically be placed in the next highest event. USATT dress code applies.

REFUND POLICY Entry fees will be refunded if tournament committee is notified at least one week prior to tournament date selected. Refunds will not be given for any withdraw-

als after that date except when the player's rating is too high for a desired event and s/he chooses not to be promoted to the next highest event. Phone/email entries are responsible for full entry fees if not withdrawn at least one week prior to start of tournament date selected. **NO REFUNDS FOR NO-SHOW PARTICIPANTS.**
