**ELIGIBILITY**  
Up to two families can form to create a single team. Teams must be a minimum of 3 players, and a maximum of 5 players. Only 3 designated players can compete during a single Team Competition. All players must sign separate release form for documentary production purposes.

**FORMAT**  
Team One with Players A, B, and C  
Team Two with Players X, Y, and Z

**TEAM COMPETITION:** first team to reach 5 of 9 Matches, as follows:

- Round 1 Matches:*  
A vs. X; B vs. Y; C vs. Z
- Round 2 Matches:*  
B vs. X; C vs. Y; A vs. Z
- Round 3 Matches:*  
C vs. X; A vs. Y; B vs. Z

**MATCHES:** first team to reach 2 of 3 or 3 of 5 Games depending on the number of entries

The winner of a Team Competition proceeds to the next round of Team Competition.

**HANDICAPS**  
**a.** 100 rating points = 1 game point  
**b.** A player can receive a maximum of positive 7 handicap points  
**c.** In matches against 2200+ players, the higher rated player gets a negative starting position. For each 100 rating points of the higher rated player above 2200, the higher rated player gets -1 game point, as follows:

HIGHER PLAYER RATING RANGE	HIGHER PLAYER STARTING POINT
2200-2299	-1
2300-2399	-2
2400-2499	-3
2500-2599	-4
2600 and above	-5

**EXAMPLE ONE**  
Player A (900 Rating) vs.  
Player B (1500 Rating)  
**The score will start at 6:0**

**EXAMPLE TWO**  
Player A (900 Rating) vs.  
Player B (1800 Rating)  
**The score will start at 7:0**  
*Even though the players' rating difference is 800, the lower rated player is only awarded the maximum of 7 handicap points.*

**EXAMPLE THREE**  
Player A (900 Rating) vs.  
Player B (2205 Rating)  
**The score will start at 7:(-1)**  
*Even though the players' rating difference is 1305, the lower rated player is only awarded the maximum of 7 handicap points. However, since the higher rated player has a rating within the 2200- 2299 range, s/he is given a starting score of -1.*

**ENTRY FEE** \$50 per team

**AWARDS** 1st Place \$400;  
2nd Place \$200; 3rd Place \$100
